## How To Register

### Option #1— Register Online

The benefits of this process include the following features:

- Registering online makes it easier to complete the online Camper Information Forms in February.
- Your information is retained for years to come, and will be ready to edit the next time you register.

Follow these easy directions to register online:

1. Visit our website at [www.ayf.com](http://www.ayf.com).
2. In the top right corner of the screen, click the **Register** button. On the next page, click **Merrowvista**.
3. Create your own password-protected account.
  - For **NEW Families**: In the New User Sign-Up section, enter the required information to set up a new account.
  - For **RETURNING Families**: If your camper was registered for 2019 camp, your family’s information has been saved in the system from 2019.
  - Once you’re logged in, just click the **Start application** button to begin the 2020 camp registration process!

**Payment Information:** A \$200 non-refundable registration fee is required for each child and program, and is applied to the camp fee. This fee, which should be in US currency, can be paid via credit card through a secure, protected processing system. *To pay with a check, select the payment option of sending a check via mail. Checks should be made payable to AYF Merrowvista and mailed to Merrowvista. Your camper will be enrolled as soon as payment is received. Registration fees are non-transferable toward siblings or second program tuition.*

**Option #2—** Contact Lisa (ext. 2011) at Merrowvista, (603) 539-6607, for assistance or to request a paper registration form. The printable registration form is also available on our website. Your camper’s spot will not be guaranteed without a completed and signed registration form.

## How to Register

Complete the online registration form or call the Merrowvista office to request a paper registration form. Registrations must be accompanied by the \$200.00 registration fee. If not paying by credit card, checks should be made payable to **AYF Merrowvista**. The registration fee is non-refundable and is applied to the camp fee. **Registration fees are non-transferable towards siblings or towards second program tuition. We are unable to process your registration(s) without the fee(s).**

We will send you the Parent Camper Handbook containing detailed information about clothing, equipment, camper health form, travel arrangements, luggage, mail, laundry, etc. in early 2020. The handbook contains forms that **must be filled out each year**, and returned to us by **April 15, 2020**.

The **deadline** for registration is **June 1, 2020**. However, because enrollment in several programs reached capacity last year, we encourage you to register early.

## Fee Payment and Billing

The non-refundable \$200 registration fee in US currency is due with the registration form. The registration fee is required for **each** child and program. When we receive your registration, we will bill you for the balance of the camp fee.

You may pay on a schedule that is convenient for you. However, 50% of the total due after payment of the registration fee is due by **February 1, 2020**. The balance of the fee is due by **April 1, 2020**. Registrations received after **April 1st** must be accompanied by full tuition payment. **Camper's showing a balance due will not be allowed to begin camp.**

Payment of tuition represents payment for services received, no portion of which represents a tax-deductible contribution.

Note: We charge a \$35 fee for returned checks.

## Credit Card Payment Option

We also offer a credit card payment option for tuition with two installments automatically charged to your credit card account. 50% of the tuition balance (after paid registration fee) would be charged on February 1, 2020, and the remaining balance would be charged April 1, 2020.

**If you would like to take advantage of this payment plan, please check the appropriate box on the registration form**, or notify the registrar with card type, card number, expiration date, three digit CVV code on the back of the card, card holder's name, the card holder's name, and billing address if different from the camper's family address.

## Discounts and Scholarships

To assist families in meeting the cost of camp, the AYF offers discounts and need-based scholarships.

### Discounts

- **Early Bird Registration** (by October 31) guarantees 2020 camp at 2019 tuition!
- **Family Discount** - After first full paying child, all summer programs for other immediate family members receive a 5% discount

### Scholarships

If you would like to be considered for a scholarship, please check the appropriate box on the registration form or e-mail the Camp Registrar, Lisa, at [lboucher@ayf.com](mailto:lboucher@ayf.com) and an application will be sent to you this fall. Scholarship funds are limited, so we encourage you to act quickly as soon as you receive your application. The \$200 registration fee must accompany the registration form, even if you are applying for a scholarship. If our award is not sufficient to enable you to attend, we will return the \$200. We will also need the signature page of your latest tax form.

Scholarships are need-based and available on a first-come first-served basis. We begin processing applications December 10. The deadline for applications is **March 1**. After March 1, you may contact the Registrar to inquire if there are any funds remaining. Due to limited funds, we highly recommend applying as soon as possible.

## Refunds

If cancellation is necessary prior to April 1, any tuition paid above the \$200 registration fee will be refunded. *After April 1st there is no tuition refund.* **There is a minimum \$35 processing fee for each refund.**

### Medical/voluntary or involuntary withdrawal

If, due to illness or injury, a camper must withdraw prior to the beginning of camp, all payments except the registration fee will be returned upon receipt of a written report from a physician. For withdrawals during the camp season due to illness or injury, a refund will be prorated. No refund will be granted in case of dismissal or voluntary withdrawal from camp and the family will be responsible for transportation costs incurred.

## Late Registrations

Registrations after April 1st must be accompanied by **full tuition payment**. We are unable to guarantee a program space without full tuition payment.
