Job Location: Position is located at Miniwanca in Shelby, Michigan. The Miniwanca site necessitates the ability to move through rugged terrain. Coordinators will live onsite during staff training and during the two camp sessions.

Job Type: Seasonal

Job Summary: The Waterfront Coordinator coordinates all waterfront activities on Lake Michigan and Stony Lake. They are responsible for the organization and supervision of waterfront staff and equipment. Summer 2024 will include two and a half weeks of paid staff training beginning June 5, followed by two three-week camp sessions. Most seasonal contracts will conclude August 11.

Position Responsibilities:

- Responsible for supporting the health, safety, and wellbeing of campers and staff in the community.
- Schedule and supervise all lifeguards and waterfront staff for their daily activities.
- Manage all waterfront equipment and facilities for both Stony Lake and Lake Michigan.
- Serve as a lifeguard at Stony Lake and Lake Michigan.
- Appropriately manage behavior issues and conflict in a way that shows respect for young people and has a focus on nurturing their social emotional development.
- Provide mentorship and connection to all campers in the community with whom you interact.
- This is not meant to be a complete list of all responsibilities. Other duties may be assigned.

Skills and Qualifications:

Required:

- Must be at least 21 years old.
- Lifeguard Certification and previous lifeguarding experience.
- Previous experience working with young children.
- Demonstrated positive leadership with young adults.
- Strong organizational and communication skills.
- Ability to effectively manage people in a way that positively supports their development.

- Strong emotional and mental health. Must be adaptable and exhibit good judgement to determine what is in the best interest of the campers in their care.
- Support the organization's mission and vision with integrity, dependability, and accountability.
- Interact effectively with individuals and groups respecting social and cultural diversity. Establish and maintain appropriate professional relationships and interpersonal skills that contribute to a positive community.
- Demonstrate passion for serving youth, encouraging campers to explore through play and creating a space where youth feel included and a sense of belonging.
- Fully participate in and be present at all camp community activities, including staff training activities.
- Maintain effective mental, emotional, and social interactions in our youth centered residential summer camp program.
- Ability to handle stressful situations appropriately, maintaining mental, emotional, and social resiliency needed for the job in a fast-paced, interactive environment.
- Use effective and appropriate self-care practices for maintaining overall wellness.
- Follow all guidelines and policies as described in the AYF (American Youth Foundation) staff manual.

Preferred:

- 3+ years of lifeguarding experience.
- Previous experience lifeguarding on open water.
- Experience with sailing and paddle sports.
- Knowledge of basic boat maintenance.

Work Environment:

- Position is located at Miniwanca in Shelby, Michigan. The Miniwanca site necessitates the ability to move through rugged terrain.
- Staff members will live onsite during staff training and during the two camp sessions, including weekends and evenings, to be available 24 hours/day in case of emergency response.
- Housing and all meals are provided.
- Staff live in a communal space with other staff or in cabins with campers, depending on position.

Compensation:

- Weekly pay: \$750/week.
- Coordinators will receive one day off for every six days worked.
